- 3. All children ministry leaders / captains working with youth or children are required to be members of Darby Creek Community Church.
- 4. Volunteers should observe the ±wo adultørule. This requires that, whenever possible, volunteers are never alone with children or youth without a screened volunteer.
- 5. Volunteers should immediately report any behaviors, which seem abusive or inappropriate to their supervisor.

I will comply with all policies and procedures of Darby Creek Community Church, including but not limited to the Children& Safety Policies listed in this form. If at any time I find that, for any reason, I am unable to support the policies, procedures, or doctrine of Darby Creek Community Church, I will resign my volunteer position. I understand and agree that failure by me to abide by such policies and procedures may result in my immediate dismissal or disciplinary action, all in the discretion of the church. I will report any known or suspected child abuse or other violation of policy to the Children& or Youth Ministry leader, pastor, an elder, or member of the church staff.
